		<b>Applicant's passport valid for at least 6 months</b> , with at least one blank page to affix the visa
		<b>One recent color passport photograph of a good quality</b> on white background
		<b>One photocopy of the data page of applicant's passport</b>
		<b>From Spain:</b> Original and a photocopy of the "Autorización de Residencia Temporal" issued by the "Delegación" or "Subdelegación del Gobierno" of the province of residence of the Ghanaian/Togolese relative who is living in Spain.
		<b>From Spain:</b> Copy of the Spanish residence card of the husband/wife living in Spain endorsed by a "Notario Público", and one photocopy of this document.
		<b>Original and a photocopy of the Applicant's Birth Certificate</b> or, in its absence, a sworn declaration of age, legalized by the Foreign Affairs Ministry of Ghana/Togo and subsequently by the Embassy of Spain in Ghana (Accra). Then, all the pages must be translated into Spanish in Spain by an authorized translator. <b>TRANSLATIONS DONE IN GHANA/TOGO ARE NOT ACCEPTED.</b>
		<b>Original and a photocopy of the Birth Certificate of the wife/husband living in Spain</b> or, in its absence, a sworn declaration of age, legalized by the Foreign Affairs Ministry of Ghana/Togo and subsequently by the Embassy of Spain in Ghana (Accra). Then, all the pages must be translated into Spanish in Spain by an authorized translator. <b>TRANSLATIONS DONE IN GHANA/TOGO ARE NOT ACCEPTED.</b>

		<b>Original and a photocopy of the Ghanaian/Togoese Registry Marriage Certificate.</b> It must be legalized by the Ministry of Foreign Affairs of Ghana/Togo and, subsequently, by the Embassy of Spain in Ghana (Accra). Then, all the pages must be translated into Spanish in Spain by an authorized translator. <b>TRANSLATIONS DONE IN GHANA/TOGO ARE NOT ACCEPTED.</b>
		<b>Original and a photocopy of the Police Report</b> issued and legalized by all the countries where the applicant has been living for the last 5 years. It must be legalized by the Ministry of Foreign Affairs of Ghana/Togo and, subsequently, by the Embassy of Spain in Ghana (Accra). Then, all the pages must be translated into Spanish in Spain by an authorized translator. <b>TRANSLATIONS DONE IN GHANA/TOGO ARE NOT ACCEPTED.</b>
		<b>Original and a photocopy of a Medical Certificate</b> stating that <i>“the applicant is not a carrier of any contagious disease, dangerous to public health, in accordance with International Health Rules of 2005”</i> . It must be translated into Spanish in Spain by an authorized translator. <b>TRANSLATIONS DONE IN GHANA/TOGO ARE NOT ACCEPTED.</b>
		If the relative in Spain has been previously married in Ghana, Togo, Spain or in another country, he/she must prove that all previous marriages have been dissolved by submitting the original and a copy of the divorce sentence. This document must be translated into Spanish in Spain by an authorized translator. <b>TRANSLATIONS DONE IN GHANA/TOGO ARE NOT ACCEPTED.</b>
		<b>From Spain:</b> One legible color photocopy legalized by a “Notario Público” in Spain of all the pages of <b>current and previous passports</b> of the husband/wife living in Spain.
		<b>From Spain:</b> Proof of Financial Support from the husband/wife living in Spain. It is advisable to provide certificates issued by money transfer enterprises (Wester Union, Ria, Small World, etc.) instead of unreadable receipts.
		<b>Family/wedding pictures</b>
		<b>Any other document considered important by the applicant and the visa officer</b>
